The Madhya Pradesh Public Service Commission (MPPSC) is an institution constituted under section 315 of the constitution, which has mandate to conduct competitive examination for recruitment of officers and executive employees for various departments of Government of Madhya Pradesh. The main objectives are to conduct the examination in free fair and transparent manner so as enkindle faith in neutrality of the commission. The commission conducts around 15 examinations per year including state civil service examination. Around 4 lacs candidates appear in these examinations every year.

The prime focus of the Commission is to:

- Ensure.
 - o integrity and sacredness of examination,
 - maintain secrecy till results are declared and
 - transparency
 - impartiality, accountability in whole process of competitive examination;
- Improve examination and evaluation practices;

To achieve these objectives, the Commission:

- Prescribe scheme of examination to select suitable candidates for advertised posts.
- Prescribe syllabus for various examinations.
- Prescribes the condition for conduct of competitive examination to select suitable candidates.
